



PARENTAL/GUARDIAN CONSENT FORM

Regulations for students under the age of 18

The school as well as the host family take big responsibility in taking care of your child. Therefore we encourage you to read the following information carefully with your child and to fill out the complete form.

Please ensure that you read all 3 pages and send back the signed form as an e-mail <u>before</u> your child starts at our school.

Classes and homework

The students have to attend every class and have to arrive on time. The class may not be disturbed. Furthermore, there should be a respectful interaction between the students and the teacher. The homework needs to be done every day.

Accommodation

Host family

- It is very well seen when the students assimilate and take part in the family's life.
- The student's rooms have to be kept clean and tidy.
- In case of damaged property the students / parents have to pay for it.
- We ask our young students to be quiet after 22:00 p.m. in order not to disturb the neighbours or other people living with you.
- Ask permission of your family if you are allowed to bring friends along.

Apartment

- The student's rooms have to be kept clean and tidy.
- In case of damaged property the students / parents have to pay for it.
- We ask our young students to be quiet after 22:00 p.m. in order not to disturb the neighbours or other people living with you.
- It is not allowed to bring friends to the apartment.

Going out at night without supervision

Because of the late dinner times (around 20:00 - 20:30) in southern Spain, people tend to go out late. In cooperation with the host family, we recommend you to allow the following curfew for your child:

15 year olds and younger: 9pm during the week, 10pm during the weekend 16 – 17 year olds: 10pm during the week, midnight during the weekend

We have to make clear that we cannot control your children permanently and advise your children to follow the rules and norms in Spain.

* Please note that the school can't supervise the minors when they stay in an apartment.

Alcoholic drinks and tobacco

It has to be noted that drinking alcohol under the age of 18 is not permitted in Spain and will therefore not be allowed in the school or school related activities. Drugs are strictly forbidden in all cases.
